

# iLearningGlobal Financial Rewards Program

iLearningGlobal has put together the most exciting financial rewards program in the industry. This is a very lucrative plan which provides you with the opportunity to make great up-front money as well as create an enormous residual income.

## Definitions

**Member** = all people paying the \$79.95/month Standard Membership fee for access to our [www.iLearningGlobal.tv](http://www.iLearningGlobal.tv) web site are iLearningGlobal Members.

**Customer / Marketer** = all iLearningGlobal Members are initially placed into the iLearningGlobal system as Customers and will remain Customers until they sponsor another Customer/Marketer. Once they sponsor another person they are moved to a Marketer status should that be their election. There is a \$20 annual fee to become a Marketer which includes your personal replicated website. There are minor fees associated with the method Marketers use to receive their commissions. See back office.

**Sponsor** = the person who enrolled you into iLearningGlobal.

**Mastermind Sponsors** = includes your Sponsor and their Sponsor all the way up. Note this is sometimes called the "sponsor tree."

**Mastermind Mentors** = our iLearningGlobal faculty.

**Mastermind Level** = this is where you or one of your Mastermind Sponsors places a new Member below you into your Mastermind Organization. For example, there are 7 Mastermind Levels in the top part of the Financial Rewards Program. The % commission you receive of the membership fee paid by someone below you is determined by which Mastermind Level they are on. The Mastermind Levels are sometimes referred to as the "placement tree."

**Mastermind Group** = the Marketers on your first Mastermind Level.

**Mastermind Organization** = your Mastermind Organization (MO) consists of all Members on all Mastermind Levels below you from your first Mastermind Level all the way down through infinity.

## Stage 1

The standard product for iLearningGlobal is a membership providing 24/7 access to the content on the iLearningGlobal.tv website for \$79.95/month. Commissions from this \$79.95 get paid out, up the placement tree, to multiple Mastermind Levels.

In order to receive commissions you must be an ILG Member paying the \$79.95/month Standard Membership fee. In addition, to be paid on different Mastermind Levels below you there are requirements on how many Customers/Marketers you must have on your 1<sup>st</sup> level (see table).

You can place Customers and Marketers that you personally enroll, on whatever level you want within 30 days of their enrollment. You will remain listed as their Sponsor no matter where you place them in the Mastermind Organization. Contact your Sponsor for more information on this strategy.

You can have unlimited first level Customers and Marketers.

## Stage 2: Premium Upgrade and Bonus

For an extra \$20 per month the Customer/Marketer gains access to our “Premium” upgrade which includes additional content and features on the website (making the total monthly subscription \$99.95). This entire \$20 upgrade fee is paid directly as a bonus to the Sponsor regardless of where they are placed in their Mastermind Organization. This bonus follows the Marketer that personally sponsored the Customer/Marketer.

Commissions paid on the \$79.95 Standard Membership fee flows through the “placement tree” according to the Financial Rewards Program outlined in Stage 1.

**Note:** You must purchase the Premium upgrade yourself in order to be paid Premium bonuses. If you are not on Premium and you enroll a Customer/Marketer in Premium then the \$20 bonus will go to the next qualified Marketer above you and will be LOCKED IN FOREVER. Also note, the next qualified Marketer above you is your Sponsor (if they are on Premium). This bonus follows the “sponsorship tree,” not the placement tree. So if you plan on enrolling Customers/Marketers in Premium you should enroll in Premium as well.

For purposes of simplicity we will call Standard Membership + Premium Upgrade our “Premium Membership.”

*\*Note: all figures in these tables represent a personally sponsored Customer/Marketer placed on your 1st level. You do have the option to move a Customer/Marketer in your organization within the first 30 days of their enrollment. This placement impacts the monthly commission but not the monthly bonus. For example, if you enrolled a person into Premium Membership and placed them on your 3<sup>rd</sup> level then you would receive the 7% commission (\$5.60) on the \$79.95, plus the \$20 bonus would still go to you because you personally sponsored them.*

### Stage 3: EDGE Upgrades and Bonuses

The EDGE program requires that you purchase either the Standard Membership or the Premium Membership in addition to the EDGE Upgrade because the program draws material from the iLearningGlobal.tv site.

The EDGE Upgrade can be paid on a monthly basis. The compensation paid to Marketers is slightly different for each option – see details below. For EDGE Monthly the bonus is paid out monthly - creating a smooth payment of commissions/bonuses over time. Below is a breakdown of the variations by program and includes a representation of the commission structures.

**Note:** You must be “EDGE qualified” in order to receive EDGE bonuses. You can be “EDGE qualified” by having 5 active personally sponsored Customers/Marketers (no matter where you placed them in the tree), or by purchasing the EDGE program yourself. If you are not EDGE qualified and you enroll someone in EDGE the bonus will go to the next qualified Marketer up the sponsorship tree above you and will be LOCKED IN FOREVER. If you plan on enrolling Customers/Marketers in EDGE and getting the bonuses for it, you must be EDGE qualified yourself.

### EDGE Monthly

There is a \$25 monthly bonus for every personally sponsored EDGE Monthly subscriber.

*\*Note: all figures in these tables represent a personally sponsored Customer/Marketer placed on your 1<sup>st</sup> level. You do have the option to move a Customer/Marketer in your organization within the first 30 days of their enrollment. This placement impacts the monthly commission but not the monthly bonus. So if you enrolled a person in EDGE Monthly and placed them on your 3<sup>rd</sup> level then you would receive the 7% commission (\$5.60) on the \$79.95 and the \$25 bonus would still go to you because you personally sponsored them. In addition to the \$25 bonus paid to the first EDGE qualified Sponsor there is some additional bonus money that flows up to the EDGE qualified sponsor tree. The next 6 EDGE qualified Sponsors will receive bonuses of \$6, \$6, \$4, \$3, \$2, and \$2 respectively. In order to receive these bonuses you must be EDGE qualified (see requirements above).*

### STAGE 4: Ambassador Bonuses

**Qualification** - a Marketer qualifies as an Ambassador in each month they have at least \$100,000 USD in volume\* under their position. The only caveat is that they cannot count more than 50% of the needed \$100,000 USD volume from any single 1<sup>st</sup> level Marketer position (sometimes referred to as a leg). In other words a Marketer can have \$100,000 USD in volume under a leg and potentially be paid on it, but they cannot count more than \$50,000 USD of that leg toward the qualification to become an Ambassador. This will require the development of volume from under a separate 1<sup>st</sup> level leg.

**Bonus earned** - once a Marketer has attained Ambassador status they earn an additional 3% of the volume\*\* down 6 generations of Ambassadors in every leg. Generation 1 – we begin paying the 3% from your first Mastermind Level down to, but not including, the first qualified Ambassador found in any leg (this Marketer begins generation 2).

Note there may be several Mastermind Levels from you down to the first qualified Ambassador in each of your legs. And there may be several more Mastermind Levels from your first qualified Ambassador in any leg down to your second qualified Ambassador in that leg, etc.

In other words, we pay on 6 generations of Ambassadors, the generation 1 Ambassador (you) followed by 5 more generations of Ambassadors in every leg. This will give each Ambassador a very deep reach and the potential to earn overrides on the volume of tens of thousands of Marketers.

It should be understood that once one becomes Ambassador he/she has an infinity reach under each position (leg) that does not have 6 Ambassadors under the position (leg). This is extremely exciting!

To retain Ambassador status a Marketer must continue to sponsor, conduct meetings and provide leadership support to their group. I LearningGlobal Ambassadors and the Advisory board will work together to determine minimum volume Requirements to retain Ambassador status.

\*Volume that counts toward Ambassador qualification – the full \$79.95 Standard Membership fee counts toward qualification as an Ambassador, and the full bonus amounts of Premium Upgrade (\$20), EDGE Monthly (\$48), and EDGE Annual (\$482) all count toward qualification as an Ambassador.

\*\*Volume on which Ambassadors are paid the 3% Ambassador bonus – is the entire volume generated from the \$79.95/month Standard Membership fee and from the \$79.95/month portion of the Premium Membership fee. Please note that a full 100% of the Premium Upgrade cost (\$20), and 60% of the EDGE Monthly and EDGE Annual Upgrades is already being paid out as bonuses, so additional commissions cannot be paid out for these upgrades.

For example, if you have \$200,000 USD in total volume (assuming they are organized correctly in order to qualify you as an Ambassador) and only \$100,000 USD of that volume is from the \$79.95 Standard iLearningGlobal subscription, then you would be paid the 3% Ambassador bonus on the \$100,000 USD volume.

### ***STAGE 5: Profit Sharing Ambassador Pools***

iLearningGlobal wants the top Marketers to share in the success of all Marketers regardless of their country of origin. It is accomplished by qualified Marketers sharing in the total monthly volume of the entire company. It is described below.

**Pool 1:** 1% of the company's monthly revenue is split equally and paid monthly to each qualified Ambassador who has no less than \$200,000 USD total group volume with no more than 50% coming from one organizational leg.

**Pool 2:** 1% of the company's monthly revenue is split equally and paid monthly to each qualified Ambassador who has no less than \$600,000 USD in total group volume. Qualified Ambassadors for this pool can have no more than 70% of their USD total group volume coming from one organizational leg.
